WHY COOPERATE WITH INTERNATIONAL MECHANISM

- TO PROMOTE YOUR OWN STRATEGIC PRIORITIES
- TO PROMOTE AN INDEPENDENT AND OBJECTIVE REVIEW
- JUSTIFICATION:
 - MANDATED IN THE PARIS PRINCIPLES
 - PROMOTED IN ICC GENERAL OBSERVATIONS



UPR RECOMMENDATIONS COMMON TO STATES IN THE MENA REGION

- GOVERNMENT AND ADMINISTRATION
- RULE OF LAW
- FUNDAMENTAL HUMAN RIGHTS AND FREEDOMS
- RECOGNITION OF KEY GROUPS
- NATIONAL HUMAN RIGHTS INSTITUTIONS



COMMON RECOMMENDATIONS – GOVERNMENT AND ADMINISTRATION

- ESTABLISHING INFRASTRUCTURE
- PROMOTING GOOD GOVERNANCE / ADMINISTRATIVE ACCOUNTABILITY
- ANTI-CORRUPTION
- IMPUNITY OF STATE ACTORS



COMMON RECOMMENDATIONS – RULE OF LAW

- RATIFICATION AND IMPLEMENTATION OF INTERNATIONAL HUMAN RIGHTS INSTRUMENTS
- A CLEAR, COHERENT AND COMPREHENSIVE DOMESTIC LEGAL FRAMEWORK
- AN INDEPENDENT JUDICIARY AND PROCEDURAL GUARANTEES FOR A FAIR TRIAL
- JUDICIAL TRAINING, AND TRAINING OF POLICE, SECURITY AND DETENTION AUTHORITIES
- EDUCATION OF THE PUBLIC



COMMON RECOMMENDATIONS – FUNDAMENTAL RIGHTS AND FREEDOMS

- RIGHT TO LIFE
- ARBITRARY ARREST AND DETENTION
- HUMAN TRAFFICKING
- FREEDOM OF EXPRESSION AND ASSOCIATION
- FREEDOM OF RELIGION

- WOMEN
- CHILDREN
- HUMAN RIGHTS DEFENDERS
- MIGRANT AND FOREIGN WORKERS
- RELIGIOUS MINORITIES



COMMON RECOMMENDATIONS – NATIONAL INSTITUTIONS

- ESTABLISH A NATIONAL HUMAN RIGHTS INSTITUTION
- STRENGTHEN AN EXISTING NATIONAL HUMAN RIGHTS INSTITUTION
- PROVIDE APPROPRIATE SUPPORT
- COOPERATE / FACILITATE OPERATION OF NHRI


